



## Home Hardware Gift Card Contest For New Members

Open a new membership at Kawartha Credit Union from April 4 to June 30, 2022 and you will be automatically entered to win one of twelve Home Hardware Gift Cards (\$50 value). Contest rules and regulations apply.

### CONTEST RULES AND REGULATIONS

#### The Contest

The contest is sponsored by Kawartha Credit Union Limited “Kawartha.” The contest begins April 4, 2022 at 9:30 a.m. Eastern Standard Time and the contest ends June 30, 2022 at 6:00 p.m. Eastern Standard Time (the “contest period”). Memberships must be opened within the Contest Period in order to be eligible to win.

#### Eligibility

The contest is open to residents of Ontario who are at least 18 years of age and who have opened a fully-funded membership at Kawartha Credit Union between April 4, 2022 to June 30, 2022. The contest is not open to employees, directors, contractors, agents or representatives of Kawartha or its affiliates, distribution companies, third party vendors or any person who is a member of the immediate family of an employee, director, contractor, agent or representative of Kawartha.

#### How to Enter

To participate in the contest, open a new Kawartha Credit Union membership with a fully-funded member share during the contest period. Each eligible, fully-funded membership opened will receive one (1) ballot. One ballot per membership opened.

#### Prize

There will be twelve (12) prizes awarded, each consisting of a \$50 Home Hardware gift card. The odds of winning a prize depend on the number of eligible memberships opened during the contest period.

#### Determination of Winners

Twelve (12) random draws will be conducted to select the winners on July 8<sup>th</sup>, 2022 at 12:00 p.m. EST by the contest judges at 14 Hunter Street East, Peterborough, Ontario. Prizes will be mailed to the winning members’ preferred Kawartha Credit Union branch by July 30, 2022.

#### Winner Notification

Winners will be verified and then contacted by a Kawartha Credit Union representative by telephone. Any selected entrant who cannot be contacted (or who fails to respond to any telephone message left for such selected entrant) within seven (7) days of Kawartha Credit Union’s first attempt to contact such selected entrant may, at the sole discretion of Kawartha Credit Union, be declared disqualified (ineligible

to win) and the contest judges reserve the right, in such event, to select at random, another entrant whom they shall attempt to contact, and who shall be subject to disqualification in the same manner.

Before being awarded a prize, a selected entrant will be required to sign a Declaration and Release Form, stating that they have read, understood and complied with these Contest rules, grant all consents required as contemplated in these Contest Rules, authorized the Contest Sponsor to publish their name and photograph in connection with any promotion or publicity at no compensation to the selected entrant, accepts the prize as offered and releases the Contest Sponsor from any and all liability of any kind arising out of the selected entrant's participation in this Contest and receipt and use of the prize, or the prize will be forfeited and awarded to an alternate winner who will be selected in a random drawing.
